INFO ON REVERSE

The NLSF has implemented the Family Trail Pass Rebate system. In past years we offered this as a discount at time of purchase. The discount was designed to allow families who had multiple snowmobiles (now tracked off-road vehicles), registered at the same civic address, a reduced rate for their second and third machines. Although registration with the NL Dept. of Motor Vehicles is a requirement, we have no access to this information for address verification. This allows numerous ways that this benefit can be misused.

As a solution, we have instated the Family Trail Pass rebate program similar to what other Atlantic provinces have. When purchased, all Trail Passes will be at the full rate, either Early Bird or Regular Season. Families can then apply, either by mail (photocopy) or email (scanned/photo), to the NLSF office for their rebate. To be approved you must include the NLSF rebate form, copies of your registrations (indicating a common address) and if purchased at a Vendor a copy of your Trail Pass Application Form.

- <sup>•</sup> Whether purchased during early bird or regular season, a discount of \$12.00 is issued for any additional machines after the first, as long as all machines are registered at the same civic address. 1<sup>st</sup> machine is always at full price, no discount given.
- o 1<sup>st</sup> tracked off-road vehicle: \$105.00 (Early Bird) or \$162.00 (Regular Season)
- o 2<sup>nd</sup> tracked off-road vehicle and up: rebate of \$12.00 for each additional machine
- \* Rebates are mailed out in cheque form.
- \* Rebate forms available on the NLSF website, at vendors and at the NLSF office.
- \* We do not accept insurance slips as replacement for registrations.
- \* For FAMILIES only. Not intended for business' or government agencies.
- \* Applications will be accepted at the NSLF office any time throughout the season and will be processed from mid-January to April 30<sup>th</sup>. Any rebates received after April 30<sup>th</sup> will not be processed.
- \* If you applied for the rebate last season and received a cheque, you will be in our system and will not have to resend your registrations. Note: if your plate number(s) have changed since last season you will have to submit a copy of the new registration(s). Rebate application form is still required.
- \* If you haven't received your rebate cheque by the end of April, please contact the office a.s.a.p. 709-635-4395. Any rebates submitted via email will have a reply sent back letting you know your submission has been received.
